# 200. MATTERS ARISING

# (i). Minute 175 (i): Movement of Long Distance Buses to Mucheke Bus Terminus

On the progress in resuscitating Mucheke Bus Terminus, the Town Clerk explained that a special Management meeting would be held to discuss modalities of mobilizing resources for upgrading the bus terminus and ancillary facilities.

# (ii). Rujeko D Housing Residential Stands

Regarding the progress on Rujeko D Housing Scheme, the Town Clerk explained that the project designs have been completed and approved. With regards to servicing of the stands, Council went to tender on expression of interest and only one bidder responded to the tender. Council therefore had written to the Procurement Regulatory Authority of

Zimbabwe (PRAZ) seeking guidance on how Council should proceed with the tender, and the response was still to be received by Council.

# 201. HEALTH, HOUSING AND ENVIRONMENTAL SERVICES COMMITTEE

IT WAS MOVED BY Councillor M. Madhuna Seconded by Councillor A. Time

"THAT the minutes of the meeting of the Health, Housing and Environmental Services Committee held on 7 July 2025 be adopted subject to the resolutions passed in relation thereto".

On minute 185 (A) (ii) on stray dogs in the Commonage, the members raised the need to engage the Society for Prevention of Cruelty to Animals (SPCA) to intensify dog collection. It was noted that a dog tie up and shoot order had been advertised in the press. Progress would be checked after the closure of the window period.

On refuse collection and disposal, the members raised the need to address the critical shortage of refuse compactors in Council. The need to introduce waste separation exercise at the point of source was raised as a strategy to enhance waste collection and disposal in the city.

On minute 186 (A) regarding the application by Tawanda Nyamarebvu, for a change of Bottle Store Liquor Development permit to a Bar Liquor Development permit on Stand Number 28119, Mushandike Street, Hillside Extension Masvingo, the matter was referred to Council in Committee for deliberations.

The Motion was moved by Councillor M. Madhuna, seconded by Councillor R. Musekiwa.

On the issue of Haulage trucks damaging municipal roads in the commonage, the Town Clerk highlighted that Municipal Police would be tasked to attend to the matter.

On water reticulation and treatment, the members raised concern that a lot of treated water was being lost through pipe bursts thereby contributing to non revenue water.

On roads maintenance, the house raised the need to attend to most of the roads in the commonage.

- 4. THAT Acting Director of Engineering Services be instructed to refer the repair of broken down Biological Nutrient Removal Plant (BNRP) components being Stirrers and Aerators to the Finance and General Purposes Committee for funding.
- 5. THAT the report of the Acting Director of Engineering Services be approved and adopted subject to the resolutions passed in relation thereto.

# 203. FINANCE AND GENERAL PURPOSES COMMITTEE

IT WAS MOVED BY Councillor B. Muchokwa seconded by Councillor M. Madhuna

"THAT the minutes of the meeting of the Finance and General Purposes Committee held on 18 July 2025 be adopted subject to the resolutions passed in relation thereto".

On water treatment and supply costs, concern was raised that cost of electricity was not sustainable, and urged Council to expedite the solar plant project at Bushmead Water Works.

On huge sums of money owed to Council by Government Departments, the house noted that the issue would need to be discussed at policy level. The members raised concern that some revenue lines were not performing as expected. The Finance Director was instructed to prepare a report on revenue collection analysis for each revenue source for a period of three months and submit to the Finance and General Purposes Committee for consideration with a view to identify non performing revenue centers so that appropriate action would be taken.

On economic Development section, clarification was sought on whether it was not possible for Council to set up the Economic Development Committee which would be given the responsibility to oversee economic development issues in the City. The Town Clerk advised that it was possible for Council to form the Committee. The idea was adopted by Council and the Town Clerk was instructed to work on the modalities of appointing the Economic Development Committee which focus on economic development in the City.

- 6. THAT the report on the operations of the Liquor Section be considered at a special meeting of the Finance and General Purposes Committee.

- 8. THAT the special meeting of the Finance and General Purposes Committee to also consider progress on other income generating projects in Council.
